REFRAMING OF THE POLITICAL AND SOCIAL DEBATE IN THE CAUCASUS REGION

Discussing Cross-Country Initiatives

<u>Rationale</u>

In the framework of the project "Reframing the Political and Social Debate in the Caucasus Region", the Toledo International Centre for Peace (CITpax) has organised the conference "Discussing Cross-Country Initiatives", to bring together representative actors from the Caucasus region to discuss –with a regional scope- on topics of common interest that are pertinent to promote cross-border security and conflict resolution as a final goal.

With the financial support of the Spanish Ministry of Foreign Affairs, the meeting is proposed as an exploratory facilitation exercise to promote dialogue on transversal issues among participants from the Caucasus Region at large. Ideally the conclusions and ideas drawn from this exercise will constitute a basis for future possible projects for the region.

Participants would be representative personalities either from the Civil Society level or officials acting as private individuals under the Chatham House Rule coming from the areas represented in the conference (i.e. Georgia, South Ossetia, Abkhazia, Armenia, Nagorno-Karabakh and Azerbaijan).

The discussion would seek to stress the view that there is room for inter-community cooperation in the Caucasus even in the shadow of unresolved political disputes. The idea behind such exercise is that reframing of the Caucasus politics does not imply denial of the conflicting interests and views. The discussion would take place in the course of one day and a half, in which the same panel of participants would first present their experiences working in the framework of cross-community (regional) projects, and subsequently they would exchange views on three different –although interrelated- subjects, namely:

- Democratisation
- Human Security
- The role of Civil Society therein

It is envisaged that, after a brief presentation of the discussion topic by the moderator, participants subsequently describe the situation in their own countries looking through the prism of the proposed subjects. Ideally these presentations will be followed by a debate among participants on how the issues of good governance, cross-border security and Civil Society activism relate to each other -as well as to conflict resolution at large.

The proposed exercise seeks to shed light on the implications that the recent political developments (such as, for instance, the current state of the Armenian-Turkish relations or the events of August 2008 in South Ossetia) may have for the future strategies of Civil Society actors in the region, without presenting, on the other hand, any pre-conceived interpretations as to the shape that these strategies should have.
